### 2025-2026 Learn DC Meal Charge Policy Public Notification Application for Free and

#### **Reduced Price Meals**

Our school participates in the National School Lunch Program (NSLP), School Breakfast Program (SBP), and After School Snack Program (ASSP) and offers free or reduced priced meals to families who qualify. All families are encouraged to submit a meal application by the first week of school – one application per household is needed. Families can at any time submit a new application if there is a change in the household income or family household number. Applications can be accessed in the front office.

This notification, in order to be compliant with federal and local regulations, is required by the United States Department of Agriculture (USDA) to notify the community (public) about the availability of LEARN D.C. Public Charter's meal program.

## **Meal Charge Policy**

Families are strongly encouraged to pre-pay for meals on a regular and consistent basis, unless they qualify for free meals.

Families who do not qualify for free meals are expected to provide funds on a timely basis for their child to participate in the meal program. As a nonprofit organization we are dependent upon all funding to support our healthy meal program.

Parents will be notified via email of low balances or an exceeded charge limit, and will be expected to immediately submit a payment so that their child may continue to eat in the cafeteria. At any time, parents may also submit an application for free and reduced meals if the household is experiencing hardship.

## **Student Pricing**

- Students who do not qualify for free or reduced-price meals must pay \$4.73 for lunch for K-5 and \$4.44 for PreK3-PreK4. Breakfast and snack are provided free of charge every school day.
- Students who qualify for free or reduced-price meals will be offered free breakfast, lunch, and snack every school day.

# **Payment Options**

• Students or Parents may pay for meals at MyMealtime.com, or with cash. Instructions on how to access the online payment system can be found here.

#### **Payment Policies**

- Students will not be denied meals for any reason, regardless of their meal debt.
- Students will be served reimbursable meals, not an alternative meal, regardless of their meal debt.
- No student will be overtly identified as receiving free or reduced-price meal benefits or as having delinquent debt.
- No action will be taken against the student in order to collect unpaid meal debt.

#### **Dietary Needs**

• Any students with food allergies must complete the dietary needs form accompanied by a physician's note, each school year. This form can be obtained through the main office.

## **Notification of the Meal Charge Policy**

The meal charge policy will be provided in writing to all families at the start of each school year and to families transferring to the school midyear. The meal charge policy will also be provided to all school or district-level staff responsible for policy enforcement.
